## Receipt for Provisional Membership

Any person who wishes to join the Society as a lineal member but has had difficulty tracing his or her ancestry to Scotland or to the Americas prior to 1870 may join as a provisional member for up five (5) consecutive years while researching the documentation needed to support eligibility as a lineal member. Annual dues are required to be paid on a calendar year basis to maintain this category of membership. Provisional members will receive all Society publications and may attend all Gatherings and other meetings of the Society, but will not have the right to vote or to hold office. Provisional members and the children of provisional members are not eligible for scholarships reserved for members or children of members. Children of provisional members are not eligible for junior memberships. Provisional memberships will automatically expire on 31 December of the fifth (5th) year after the application was submitted and shall not be extended or renewed beyond that date. Any person may apply at a future date for lineal membership.
